I. Essential Qualification:

Eligibility A

- i) Master's degree with 55% marks (or an equivalent grade in OGPA/ a point-scale wherever the grading system is followed) in a concerned / relevant /allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- ii) Ph.D. degree (with course work) in concerned/ relevant /allied subject as prescribed by the UGC Minimum Standards and Procedure for Award of M.Phil / Ph.D. Degree) Regulations-2009 or the UGC Minimum Standards and Procedure for Award of Ph.D Degree) Regulations-2016 read with amendments thereto from time to time.
"However, Ph.D Degree is relaxed for the post of Assistant Professor-cum-Junior Scientist across all the disciplines in the University upto 30.06.2023".
- iii) National Eligibility Test (NET) conducted by UGC, ICAR, CSIR or a similar accredited State Eligibility Test (SLET/SET) on the last date of submission of application.

OR

A candidate who have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009 or 2016 read with amendments from time to time is exempted from NET/SLET/SET.

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the Degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor-cum-Junior Scientist or equivalent subject to the fulfillment of the following conditions :-

- a. The Ph.D. degree of the candidate has been awarded in a regular mode only;
 - b. The Ph.D. thesis has been evaluated by at least two external examiners;
 - c. An open Ph.D. viva voce of the candidate has been conducted;
 - d. The candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
 - e. The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/ funded/ supported by the UGC/ICSSR/CSIR/ICAR or any Government Agency /PSUs
- (a) to (e) above are to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned
- iv) NET/SLET/SET shall not be required for the candidates in such disciplines for which NET/SLET/SET is not conducted by the ICAR, UGC and CSIR.

OR

Eligibility B

The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:

- (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

The candidate's ability for teaching, research and extension aptitude shall be assessed through a seminar/lecture in a classroom situation or discussion during the interview.

Essential qualification for engagement of Contractual/ Guest Lecturers in English appearing under S. No. 02 (FoA) above ;

- Masters Degree with minimum 55% marks or equivalent grade in OGPA or equivalent Post-graduation qualification in the concerned subject.
- Preference : Ph.D in concerned subject/NET
- Age: As per the Statutes

Minimum Desirable Skills & Experience:

- Knowledge:** Should possess adequate knowledge of basic theoretical and applied aspects of the discipline as evidenced by outstanding academic performance indicators.
- Communication:** Should be an effective communicator for instructional responsibilities of academic courses as evidenced by teaching and extracurricular assignments.
- Teaching:** Should be well versed with the NEP-2020 and its application to Agricultural Education. Should have outstanding skills of student engagement and mentoring towards building a competent human resource pool. Trained in modern teaching pedagogies and content development.
- Scholarly output:** Should possess strong science communication skills evidenced by high impact publications in reputed scientific journals, higher h and i-10 index.

General Terms & Conditions

- The performance shall be evaluated periodically and in case of unsatisfactory or under performance, the contractual engagement can be terminated without any notice.
- The engaged person shall have no right to claim extension or regular appointment or absorption in SKUAST-K service merely on the basis of having rendered contractual service on academic arrangement.
- The engagement shall be purely temporary on academic arrangement basis for the period in the disciplines and at the Faculties as shown above against each and shall be terminable any time without assigning any reason and/ or on filling up of the post on regular basis.
- Consolidated monthly remuneration of Rs. 28000/- shall be paid to the selected candidate from the date of his/her physically joining the place of posting till the date of completion of the term of engagement.
- The candidate must not be on rolls in any Institute/University/Department for pursuit of any academic Degree programme within or outside the Country or must not be in employment in any government or non-government organization during the currency of the engagement as Contractual/ Guest Lecturer and if found so, the engagement shall automatically forfeit and appropriate action as warranted under rules shall be initiated.
- The University reserves the right to defer and/ or cancel the Walk-in-Interview and/or increase/ decrease the number of slots indicated herein-above.

- Interested eligible candidates shall report for Walk-in-Interview in the Directorate of Education, Shalimar along with application supported with self attested documentary proof in the prescribed format available on University website www.skuastkashmir.ac.in duly addressed to the Director Education, SKUAST-K Shalimar affixed with recent photograph and brief bio-data full details of academic records and personnel information.


