- 1) Who are eligible to apply:-

- a) The service of Re-Engaged Retd Railway Employee can be terminated normally after giving a notice period of one month or without notice at any time in case of unsatisfactory working/ on completion of 65 years of age or indiscipline.

3) Selection/Suitability

All the retired employees who applying and have not attained 64 years & 6 months on the closing date of notification (to ensure at least six months service is available after re-engagement) for reengagement purpose will be eligible subjected to the following:-

- a) Safety Record for last 5 years and/or service record for last 5 years must be examined of the willing employee. Retired employees must not have undergone any punishment as a railway employee for the above period.
- b) Status of APAR for last three years to be checked.
- c) Retired employees should not have taken voluntary retired/compulsory retired or removed/dismissed etc.
- d) Select panel will be finalized on the above conditions. No written examination is required. Suitability/competency of the applicant/merit cum utility of the retired employee will be adjudged by nominated committee before their re-engagement issue of panel.
- e) The staff can be posted at any station over Moradabad Division as per requirement of staff.
- f) Selected retired railway employee to be placed on panel and to be engaged on basis of merit as per requirement of GSU/MB.
