Applications are invited for filling up of one post of Deputy Chief Medical Officer (Specialist) (post code MD/DCS/01) in the Class I Scale of Pay of Rs.60000-180000 in V.O.Chidambaranar Port Authority by Absorption/Deputation method from the eligible and Willing Officers of Major Port Authorities fulfilling the eligibility criteria prescribed in the Recruitment Rules for the said post.   - ii. Attested photocopies of all certificates and proof of educational qualification, present and past work experience in the respective post and pay scale.
  - iii. No objection certificate from the respective Port.

- iv. Certificate by the Head of the Office of the applicant in Annexure-III
- v. An undertaking of the applicant not to withdraw his/her candidature, if selected.
- vi. Vigilance/ Administrative Clearance of the applicant is to be furnished in the format in **Annexure IV** prescribed by the Ministry of Ports, Shipping and Waterways vide letter No.A-12022/10/2005-PE.I dated 27<sup>th</sup> August 2010 (copy enclosed).
- vii. The veracity of the qualification certificates and the recognition of the degree obtained by the applicant may be ensured and certified.
- viii. If any major or minor penalty has been imposed on the applicant during the last 10 years, the disciplinary case leading to such penalty along with necessary documents may be sent by the forwarding authority along with the application.
