- A. Qualification:- MBBS degree from recognized University/Institute.
- B. Age:- Age on date of interview shall be 30 years for General candidates, 35 years for SC/ST and 33 years for OBC candidates, in accordance with circular No. F.No.121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi.
- C. Pay: Basic of Rs. 56100/- in Pay Matrix 10 of 7<sup>th</sup> CPC with other allowances as admissible per month.
- D. Internship:- Must have completed internship after 27.07.2021.
- E. Must be registered with Delhi Medical Council.
- F. Appointment will be initially for a period of six months extendable up to maximum of one year on the basis of satisfactory work & conduct report from the concerned HOD and written request from the doctor concerned.
