2. Such Retired Officers, applicant should not have undergone any major punishment (SF-05) in the last 05 years.
3. The age of the candidate should be less than 65 years at the time of re-engagement.
4. (a) The officer to be engaged in Civil Engg. Deptt. is required to undertake the following works –



#### Terms of references

#### **(C) Consultant (Electrical) :**

1. Consultant (Elect.) will be posted under Dy.CEE/C. He will directly report to Dy.CEE/C to whom he is attached to from time to time.
2. He will assist Dy.CEE/C in supervision/ monitoring of Construction activities in New line/ Doubling/ Traffic facility/ ROB/ RUB/ Building works/Station Development/2x25 KV/RE works etc.
3. He will assist in chasing various issues pending with State Government & other Govt departments, such as utility shifting, power line crossings/ shifting/Modification, new TR line etc.
4. He will assist in chasing various approvals of ESPs/ SIPs/LOP/ EIG/CRS papers etc. with divisions/ HQ etc.
5. He will assist in managing/ procurement of Electrical store items & other resources for smooth progress of the Project activities.
6. He will assist in preparation of various reports such as PCDO, Audit report, other reports asked by HQ from time to time.
7. Any other duty as assigned by the concerned Dy.CEE/C.

4. Suitability /Competency of the retired officers shall be adjudged before such re-engagement by a committee of three PHODs/CHODs.
5. While re-engaging such officers, medical fitness of the appropriate category shall be obtained from the designated authorities as per existing practices.
6. The period of re-engagement shall be initially for one year and further extendable as per requirement.
7. Maximum age limit of the re-engagement shall be 65 years.
8. The engagement of consultant shall not be considered as a case of re-employment.
9. 12 days leave in a calendar year on pro-rata basis in admissible.
10. Re-engaged officer shall not be entitled for requisites such as HRA, CCA, Transport Allowance, Residential accommodation etc. However, when required to travel in connection with official work, TA/DA admissible to regular employee working in the same Grade will be admissible.
11. The designation shall be consultant followed by (trade name) *i.e.* officer appointed against the post of ADEN may be designated as Consultant.
12. Re-engaged officer shall be given the responsibilities like inspections, Supervision, Drawing etc.
13. Re-engaged officer shall not be made in charge of the unit like Branch Officer in the Division or independent in charge in the Construction unit.
14. Re-engaged shall not be given the financial and D&AR powers and shall not be authorized to issue any safety certificate.
15. The consultant shall not divulge any information gathered by him/her during the period of assignment related to the organization to anyone who is not authorized to know/have the same.
16. Re-engaged officer shall be discharged immediately on joining of selected candidate(s) from UPSC or departmental selection or as per the recommendation of PHOD/CHOD concerned.
17. Monthly remuneration of a retired officer will be given according to Railway Board's letter no.2018/Trans Cell/S&T/Contractual Staff dated 25.10.2018.
18. The re-engaged retired officer shall sign an agreement of confidentiality with the Railway containing a clause on Ethics and Integrity.
19. The re-engagement can be terminated without any notice and without any explanation or any reason.



1. वह नई लाइन/दोहरीकरण/यातायात सुविधा कार्यों आदि में निर्माण गतिविधियों के पर्यवेक्षण में संबंधित एसएजी/जेएजी(एसएंडटी) अधिकारी की सहायता करेंगे।
2. वह बाहरी एजेंसियों, मंडलों और अन्य विभागों के पास संबंधित विभिन्न मुद्दों जैसे योजनाओं की स्वीकृति, यूटिलिटी शिफ्टिंग आदि को चेज करने में सहायता करेंगे।
3. वह डिवीजनों/मुख्यालय आदि के साथ एसआईपी/एसडब्ल्यूआरडी/ एसडब्ल्यूआरआदि के विभिन्न अनुमोदनों को चेज करने में सहायता करेंगे।

**Sub: Re-engagement of Retired Gazetted Officers in Exigencies of Services.**

**Ref: (1) PCPO/CR's letter no. P/HQ/R/952 dated 21.08.2018.**

**(2) Board's letter No. E(NG)-II/2007/RC-4/CORE/1 dated 16.10.17.**

Keeping in view the difficulties being experienced by Zonal Railways due to vacant posts of Gazette Officers and with reference to letter at (1) above, Board (MS, FC & CRB) have approved re-engagement of retired officers in Junior Scale (only) as consultant in exigencies of the services against the vacant posts, with following conditions:


1. General Managers are empowered to re-engage the retired officers.
2. The Terms of Reference (ToR) of the work to be assigned shall be prepared and approved by GM and same shall be advertised as part of the application.
3. Railway shall give publicity to such re-engagement, by publishing such requirements on Railway website with the eligibility criteria & application form.
4. Suitability/Competency of the retired officer shall be adjudged before such re-engagement by a committee of three PHODs/CHODs/SAG as appointed by GM.
5. While re-engaging such officers, medical fitness of the appropriate category shall be obtained from the designated authorities as per existing practices.
6. The period of engagement shall be initially for one year and further extendable as per requirement.
7. Maximum age limit of the re-engagement shall be 65 years.
8. The engagement of consultant shall not be considered as a case of re-employment.
9. 12 days leave in a calendar year on pro-rata basis is admissible.
10. Re-engaged officer shall not be entitled for requisites such as HRA, CCA, Transport Allowance, Residential accommodation, etc. However, when required to travel in connection with official work, TA/DA admissible to regular employee working in the same Grade will be admissible.

11. The designation shall be consultant followed by (trade name) i.e Officer appointed against the post of ADEN may be designated as Consultant (Engg.)
12. Re-engaged officer shall be given the responsibilities like inspections, supervision, drawings, etc.
13. Re-engaged officer shall not be made in charge of the unit like Branch Officer in the Division or independent in charge in the Construction unit.
14. Re-engaged officer shall not be given the financial and D&AR powers and shall not be authorized to issue any safety certificate.
15. The consultant shall not divulge any information gathered by him/her during the period of assignment related to the organization to anyone who is not authorized to know/have the same.
16. Re-engaged officer shall be discharged immediately on joining of selected candidate(s) from UPSC or departmental selection or as per the recommendation of PHOD/CHOD concerned.
17. Monthly remuneration of a retired officers being re-engaged be determined by reducing Pension-from his/her last pay drawn (i.e. Basic Pay +DA).
18. This scheme is experimental in nature and is valid for two years from the date of issue of the letter.

**Sub.: Operationalization of Gati Shakti Units in the Divisions.**

**Ref:** 1. Board's letter no. 2021/W-I/Genl./Gati Shakti dtd 27.07.2022.  
2. Board's letter no. 2017/W-I/Genl./Board Meeting dtd 16.05.2022.

On the subject above, series of review meeting with the Gati Shakti Units were held to ascertain the status of works being undertaken by the Gati Shakti Units consequent to the instructions issued dated 27.07.2022. In the course of review a number of issues were discussed and clarified. The following may accordingly be ensured by the GM/DRMs


**Nodal officers** of Gati Shakti Units in Zonal HQ are different in different Railways. It is decided that AGM should be uniformly nominated as Zonal coordinator [to be assisted by CPD/CE(SD)] for the Divisional Gati Shakti Units in the respective Zones.

1. Some of the units raised the issue that PMS & PSSA are not permitted for Divisional Gati Shakti Units. It is clarified that the Para 3.1 of Railway Board letter dated 27.07.2022 clearly indicates and addresses the issue.
2. In terms of Para 7.0 of the letter in ref (1) above, house retention is allowed at the previous place of posting for one year or scholastic year whichever is earlier. It is further clarified that "CPM/GS will be eligible for house retention at previous place of posting". Outstation CPM/C posted in field under CAO/C will also be eligible for house retention at previous place of posting on similar basis.
3. Most of the CAO/C and Divisional Gati Shakti Units have represented issues in office management and shortage of staff & officers. Following provision are provided for smooth functioning of these units to mitigate shortage of skilled manpower:
  - i. The CPM/GS and CAO/C units may engage project office support service agency / General Consultants for technical support/assistance in office management. This provision is in addition to PSSA (provision for works on BOQ basis) and PMS (provision for EPC contacts). The project office support service agency / General Consultants being deployed for office work also will assist the officers of Gati Shakti Units in coordination with the project specific PSSA/PMS within estimate provisions.
  - ii. The Division Gati Shakti Units have already been permitted to engage retired Senior Supervisors belowage of 65 years with approval of GMs.
  - iii. In majority of Gati Shakti Units, the posting of Junior/Senior scale officers is still awaited. GM/DRMs to ensure posting of JS/SS officer by suitably redistributing the work among officers of HQ, Divisions, Extra Divisional units and releasing surplus officer for posting in Gati Shakti Units. Care, however, has to be taken that officers and staffs in construction organizations who are executing major infrastructure projects are not depleted. Wherever there is still shortage, retired JS/SS/JAG officers of age below 65 years can be engaged in Gati shakti units and construction organization with approval of GMs. However, the number of such retired re-engaged officers can be limited to 2 (two) for each Gati Shakti Units and 5 (five) for each CAO/C Unit.

iv. Fresh candidates from RRB have already been allotted to Zonal Railways. Board has also advised to GMs vide letter No. E(NG)/2022/TR/32 dated 24.08.2022 to depute adequate number of SSE/JE to CPM/GS and CAO/C Units. GMs office to distribute these supervisors by name to CAO/C and CPM/GS of Divisions duly taking into account their requirements, in order to ensure that there is no delay in allocating this manpower for execution of projects.

4. It was noted that in a number of the Divisions, the CPM/GS and Dy. CPMs are yet to be posted. Most of the Electrical and S&T officers are posted on looking after basis. This will hamper the works assigned to divisional Gati Shakti Units. GMs may ensure posting of required officers in place duly redistributing the workload among available officers.
5. It was noted that in most of the Gati Shakti Units, DFM/ADFM have been detailed for Gati Shakti Unit on additional charge basis which may hamper the Gati Shakti Units functioning. Exclusive JS/SS officer and section officer of Finance department may be posted to the extent possible in the Gati Shakti Unit. His/Her overall supervision will continue to be with Sr.DFM as per Para 1.7 of the letter dated 27.07.2022.
6. Some of the GMs have sought powers similar to CPM/GS for CPM/Const. The provisions in Para 1, 2 and 3 above and powers given in letter dated 27.07.2022 can accordingly be utilized for CPM/Const. posted in field.
7. Some of the DRMs have raised the issue of non-uniform constitution of T.C. in all Divisions. It was clarified that as per extant Model Schedule of Powers- 2018 (MSOP-2018), the constitution of Tender Committees falls under the purview of Zonal Railway. For uniformity among all Gati Shakti Unit of Divisions, GM may nominate SAG level T.C. for works cost above 20 crore & up to Rs.50 crore. Whenever SAG finance officer is not available locally, local JAG/SG finance officer may be nominated as per similar provision in para 3.1 of Model SOP, Part - D & Rly Bd. letter no 85/F(S) I/PW/7/I of 27-05-1987.
8. Network Planning Group (NPG) should be formed at Zonal HQ & Division level as advised vide letter no 2021/W-1/Genl./Gati Shakti dated 28.10.2022 to have synergy and integrated projects planning.
9. The transfer of works to Gati Shakti Units should be done judiciously by GMs keeping in view relative capacity of GSU and construction organization to execute the concerned work, to avoid delays in completion/targets. However, **Amrit Bharat Station** works which do not involve large scale upgradation, will be generally assigned to Gati Shakti Units of Division in view of day to day coordination with divisional officers during execution of such brown field works.


