Identified post for Person with Disabilities [PWD]

Only when there is no person with benchmark disability available for the post, the employer shall fill up the vacancy by appointment of a person, other than a person with benchmark disability, as per office memorandum dated 15.01.2018 issued by Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training.

The person who suffers from not less than 40% of disability will only be eligible for the benefit of reservation and other relaxations under PWD category as permissible under the rule. The applicant must have a valid Disability Certificate issued from the competent authority. i.e., Medical Board duly constituted by the Central or State Government. Certificate issued by the Medical Practitioner, Hospital or any other Institution will not be considered. The Physical disability of finally selected candidates would be ascertained by a Medical Board of the Institute specifically constituted for this purpose, if deemed necessary.

Important Instructions:-

- (a) All the interested candidates are requested to appear for document verification along with filled application form as attached within the scheduled time (09.00AM 11.00 AM) with proper protection like wearing face mask and carrying sanitizer and maintaining social distance. The registration for document verification will be closed at 11.00 AM and No candidate will be entertained to attend document verification after 11.00 AM.
- (b) Only those candidates whose documents are verified will be allowed to attend walk-in interview.
- (c) The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria in all respects as on the date of interview.
- (d) Reservation of posts is applicable as per Government of India Guidelines.
- (e) **Two Posts** in Junior Resident (1 year) are horizontally reserved for PwD category in identified posts.

REQUIREMENT OF QUALIFICATION AND REGISTRATION

Junior Resident (1 year)	 MBBS Degree from NMC recognized Medical College / Institution. Candidate must have completed Compulsory Rotatory Residential Internship and must produce internship completion certificate at the time of interview. Should have registered with NMC or State Medical Council.

Age Limit: Not exceeding 30 years as on date of interview. (Age Relaxation of SC/ST/OBC/PH candidates as per Government of India rules in respect of vacancies reserved for them)

The relaxation in upper age limit for SC/ST candidates is up to a maximum period of five years (05 years). In case of persons with Benchmark Disability (PwBD) candidates, age relaxation is up to a maximum period of fifteen years (15 years) for SC/ST candidates. No age relaxation would be applicable to SC/ST/OBC candidates applying for unreserved vacancies.

<u>Consolidated Remuneration</u>:- Rs. 1, 10, 742/- (Rupees One Lakh Ten Thousand Seven Hundred and Forty Two only). No other allowances in any form shall be admissible. In addition to consolidated remuneration, transport allowance with DA on transport allowance will be paid as per rules.

Total Gross Emoluments drawn by a Junior Resident for the month of July 2023 is Rs. 1, 20, 965/- (approximately) and this remuneration will be revised whenever there is revision of rates of DA as per ESIC Hqrs. Office which is line with the Central Government Employees.

The consolidated remuneration will be revised whenever there is revision of rates of DA as per ESIC Hqrs. Office Memorandum no. Z-17/11/1/2007/Med.IV (Pt.file) dated 13.04.2022.

General Terms and Conditions

Terms of Contract:

- 1. The engagement will be for **one year only** under consolidated remuneration basis.
- 2. The contractual engagement will be subject to the following:
 - a. Barring serious misconduct/irregularity, continuation of the incumbent would be based on satisfactory performance of the duties assigned.
 - b. The contractual engagement may be terminated / discontinued on either side giving one month prior notice to this effect without assigning any reason.
- 3. Rules for Reservation will be implemented as per Govt. of India instructions.
- 4. The engagement shall not confer any right or preference for regular appointment.
- 5. The Junior Residents will be entitled for one day paid leave for every completed month of service. No claim for any service benefits like Leave encashment, PF, Pension, Gratuity, Medical allowances, Medical benefits, Seniority, Promotion etc. will be admissible.
- 6. Candidate in the Government Service should submit "No Objection Certificate" from the employer at the time of interview.
- 7. The candidates who are already employed must produce relieving order from the previous employer at the time of joining / NOC for taking up engagement with ESIC.
- 8. No TA/DA will be admissible for interview or joining.
- 9. ESI Corporation may increase or decrease or cancel filling up of any or all posts without assigning any reason at the discretion of the Appointing Authority.
- 10. Candidates applying in OBC/SC/ST/EWS/PWD Category must possess the certificate issued by competent authority, valid for admission/ job in Central Govt. Institutions issued before the date of interview, failing which <u>he/she shall not be allowed to appear in interview for the</u> <u>reserved category</u>. However, he/she can be treated as UR Candidate.
- 11. The candidates claiming reservation on grounds of belonging to **OBC** [non-creamy layer] should submit the community certificate in Annexure "A" prescribed vide Govt. of India, Department of Personnel and Training O.M No. 36036/2/2013-Estt (Res) dated 30.05.2014 failing which the benefits of reservation will not be given and their application shall be rejected and no request /correspondence will be entertained. Certificate issued in other formats will not be accepted and the candidature will be treated as "General Category" for all purposes.
- 12. The candidates appointed under PWD quota will be adjusted against the vacancy of respective categories of SC/ST/OBC and UR quota. The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Government Hospitals/Institutions.
- 13. The DEAN has the discretion to increase/decrease the number of vacancies depending on actual requirement or to cancel this recruitment or to withdraw offer of engagement.
- 14. The Junior Resident so selected will be required to submit acceptance/consent letter in writing before appearing for medical examination.

- 15. The Junior Resident at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of the notice period.
- 16. The absence from work for a period of fifteen days without proper permission of the competent authority will amount to voluntary abandonment of engagement and automatic termination. The Medical Officers are required to mark attendance manually as well as on Aadhar Enabled Biometric Attendance System (AEBAS) daily during scheduled working days.
- 17. They will also be required to attend emergency, floor duty and other clinical duty as assigned by the Competent Authority.
- 18. They will also be required to perform duties in other departments as assigned by the competent authority.
- 19. Selected candidates will have to join duty on or before the date indicated in the offer of appointment/engagement.
- 20. The Junior Resident so engaged will be required to enter into a contractual agreement for the purpose on a **stamp paper of Rs.100/-.**
- 21. The Selected Junior Resident candidates have to deposit security amount of Rs.15,000/- (Rupees Fifteen Thousand) in favour of ESI Fund A/C No. 1 payable at State Bank of India, Ashok Nagar, Chennai-78 and produce the demand draft at the time of joining. - (ii) The applications of the candidates submitted on the day of walk in interview along with the requisite fee will be scrutinized by the scrutiny committee of the Institute and only the eligible Candidates will be allowed to appear for walk in interview before the selection committee. In case, the numbers of applicants are in the ratio of 1:10, the selection committee of the Institute may devise criteria for short-listing of the candidates which may include holding of a Screening Test.
- (iii) The selection for engagement as Junior Resident will be made solely on the basis of performance of the candidate in interview before the Selection committee. Merit list for selection will be prepared solely in accordance with the performance of the candidates in the interview. Reservation will be applied at this stage for selecting the candidates under each category.
- (iv) Result will be published on the website (<u>www.esic.gov.in/recruitments</u>).
- (v) ESIC Medical College and Hospital, KK Nagar, Chennai is in urgent requirement of Junior Residents. Hence, selected candidates will have to join immediately after receipt of the offer of engagement not later than the last date mentioned in the offer of engagement. Request for extension of time for joining the post will not be considered.

General Instructions:
