A walk in interview for engagement of Junior Residents on regular basis is scheduled to be held in IGH, Dwarka on 18.10.2023 (Wednesday), with vacancy status as follows:-

All eligible candidates who are interested for the same are requested to report at 09:30 AM on 18.10.2023 to Library, 5th Floor, Admn Block, Indira Gandhi Hospital, Dwarka along with duly filled proforma annexed with this notice, a set of self-attested copies of all certificates, marksheets and two passport size photographs. Original certificates/documents are also required at the time of interview for verification. Candidate's reporting after 11:30 AM will not be considered for the interview.

Only those candidates are required to report who fulfill the eligibility criteria as Residency Scheme and following criteria.

- 1. Qualification: MBBS Degree from a NMC recognized university/Institute with internship completion certificate. Foreign Graduates must have cleared FMG Examination. The candidate must not have done junior residency of one year from any recognized institute.
- 2. **Age Limit:** For General Candidates 30 years as on date of interview relaxable for SC/ST by 05 years and for OBC (Delhi) by 03 years (**OBC** (**Delhi only**).

Relaxations for - PwD as per rules.

- 3. Internship: Must have completed one year rotatory internship after completion of MBBS/passed FMG examination on or after 18.10.2021.
- 4. Registration: Must have valid DMC Registration as on date of interview.
- 5. Pay Scale: The pay matrix of Level 10 (Rs. 56100-177500), plus other usual allowance as admissible under the residency rules.
- **6. Tenure:** The tenure of Junior Resident on regular basis is for a period of one year including any service rendered as Junior Resident earlier on adhoc/regular basis in any recognized government institution. The appointment will be initially for a period of six months that can be extended further upto a period of one year subject to satisfactory performance work and conduct report from concerned HoDs and on written request from the doctor concerned.

Note: In case of non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of relaxation of provision circulated as per circular dated 10.06.2011 of Department of H&FW, GNCTD.



GENERAL TERMS AND CONDITIONS

- 1. Number of the vacancies is provisional and subject to change without any notice.
- 2. OBC/EWS certificate issued from Govt. of NCT of Delhi shall only be accepted.
- 3. OBC candidate must have non-creamy layer certificate alongwith OBC Certificate issued by Govt. of NCT of Delhi of current Financial Year (2023-2024).
- 4. Outside Delhi OBC candidates will be treated in the UR Category.
- 5. EWS certificate of current Financial Year (2023-2024) shall only be accepted.
- 6. In case of SC/ST/OBC/EWS certificate reveals that the claim to belong to these categories is fake/false the services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of fake/false certificate
- 7. Benefit of reservation will be granted only on the basis of caste certificate issued by the competent authority and production of original certificate.
- Selection/appointment is purely on provisional basis, subject to verification of educational certificates and other related certificates/antecedents/DMC certificate and the candidate being found medically fit.
- The service condition will be regulated as per the rules in the Residency Scheme, Ministry of Health & Family Welfare, Govt. of India of 1983.
- 10. Candidates if working on adhoc/regular basis must produce NOC from present employer.
- 11. No TA/DA will be paid to the candidates called for the interview.
- 12. In case of number of applications are very high the interview may be continue on the next day.
- 13. Selected candidates shall be allowed to join within 07 working days from the issue of the offer letter failing which the offer shall stand automatically cancelled. No extension for joining will be considered.
- 14. Mode of selection will be through interview only.
- 15. In case of any inadvertent error detected at a later stage the same will be rectified as per rules.
- 16. Competent Authority reserves the right of any amendment or cancellation of the advertisement at any stage.
- 17. Competent Authority reserves right to decide in case of any dispute with regard to selection process.
