The eligibility & conditions for recruitment of Junior Residents in the Dentistry Department, GTBH are given as under:-

1. Qualification:-BDS Degree from a recognized University/Institute.

2. DDC Registration:

- a) The candidate must be registered with Delhi Dental Council at the time of submission of application; or
- b) The candidates must be applied for with Delhi Dental Council at the time of submission of application; or
- c) The candidates, holding inter-state or intra-state valid Registration with any State Dental Council of the Country is eligible for their candidature being considered for appointment to a post/position by any of the Medical Institutions functioning under Govt. of NCT of Delhi or elsewhere. However, once the job is offered, they are required to get his registration transferred to the Delhi Dental Council as per provisions of Section 46A of the Dentists Act, 1948 mentioned in the letter bearing No.DDC/Inter-state/Intra-state registration/2009/1439 dated 22.12.2009 issued by Dr. Mahesh Verma, Registrar (DDC).
- 3. <u>Internship</u>:- The candidates, who have completed internship before 19.10.2019 i.e. four years from the last date of submission of application, are not eligible.
- <u>No. of candidates</u>:- Only five times the No. of vacancies (in each category) will be called for interview as per merit list of NEET (PG-MDS) rank conducted in 2023. After that weight-age would be 80% for NEET (PG-MDS) rank conducted in 2023 & 20% for interview for selection.
- 5. <u>Admissible Emoluments</u>:- Rs. 56,100/-+ NPA + other allowances in Pay Level 10 (Index-1) as admissible under the rules.

- Citizenship:- The candidates should be Indian citizen.
- 7. Age limit: The upper age limit will be 30 years as on the last date of submission of application. The relaxation of 05 years for SCs/STs and 03 years for OBCs will be applicable. The relaxation of 10 years for PwDs will also be applicable.

8. Tenure:

- (a) The initial appointment on regular basis is for a period of 06 months tenure, which will be extended for further 06 months after due recommendations by the HOD (Dentistry). The total period of Junior Residency will be 01 year only.
- (b) If any post remains vacant due to non applying/non-availability of particular category candidates, the same may be filled from suitable candidates of any other category on Ad-hoc & Emergent basis for a maximum period of 44 days or till the fresh incumbents join on regular basis, whichever is earlier & their appointment may be terminated earlier on joining of Junior Resident (Dental) on regular basis.
- Note: The candidates, who have already worked in any Govt. Hospital as Junior Resident (Dental), the period as worked, will be counted to calculate the total period of one year Junior Residency.
