Applications for the under mentioned vacant post(s) can be done online on the Mizoram Public Service Commission's online portal <https://mpsonline.mizoram.gov.in> till **10/11/2023**.

Examination for this post shall be held together with 1 post of Asst. Director (Town Planning) already advertised by Mizoram Public Service Commission vide Advt. No. 15 of 2023-24 Dt. 18th July, 2023.

Wherein, candidates who have already applied for the said post (Advertisement No.15 of 2023-24) need not apply, their candidature shall be for the combined posts.

Applicants must verify that their applications are submitted after payment is done. Fees once paid will not be refunded. However, if due to technical error, more than one payment is made for the same post by the same applicant, the excess payment may be refunded.

Persons with Disabilities are exempted from payment of application fees.

3. **Classification** : *Group 'A' (Gazetted) (Non-Ministerial)*
4. **No. of Posts** : *1 (One)*
5. **Pay** : *Level 10 in the Pay Matrix (Rs.56,100 – Rs.1,24,500)*
6. **Eligibility Conditions** :

1) Educational Qualification:

Bachelor Degree in Planning or its equivalent as considered by the Institute of Town Planners, India.

Desirable:

- i. Master Degree in Planning.
- ii. Associate Member of Institute of Town Planners, India (ITP).

2) Working Knowledge of Mizo Language of at least Middle School standard.

3) Age Limit:

A candidate must be between 21 years and 35 years of age on the last date of application. Upper age limit relaxation will be as per Notification No.A-12011/1/2019-P&AR (GSW) dt.3.6.2019 (published in the Mizoram Gazette Extraordinary, Issue No. 375 dt.10.6.2019) as amended from time to time. For age proof, HSLC/HSSLC Certificates which clearly shows the candidate's date of birth shall be accepted. In the absence of date of birth in such certificates, the relevant documents issued by the competent authority may be accepted.

Provided that the upper age limit in all recruitment rules/service rules for Group 'A', 'B', 'C' and 'D' posts under the Government of Mizoram where upper age limit prescribed for direct recruitment is 35 (thirty-five) years shall be 37 (thirty-seven) years for direct recruitments in various posts under the Government of Mizoram for advertisements likely to be made after the commencement of these rules during the Calendar years of 2023 and 2024

7. **Disqualification** :

- iii) Any candidate who, on verification at any stage of the recruitment process, does not fulfil any of the eligibility conditions, will be disqualified.


