**WALK-IN-INTERVIEW FOR THE POST OF SENIOR RESIDENTS AND JR. RESIDENTS (MBBS & DENTAL), ON ADHOC BASIS IN DELHI PRISON ON 28.11.2023, 29.11.2023 and 30.11.2023.**

The Central Jail Hospital, Prison Department, GNCT of Delhi will hold a Walk-In-Interview for filling up the vacant posts of Sr. Residents, in the following Department & Jr. Residents (MBBS & Dental), on adhoc basis. Only those candidates may appear for the interview who fulfils the eligibility criteria as per Residency Scheme of the Govt. of India and the qualification/eligibility criteria as given below:-

The details regarding educational qualification, emoluments, age limit, terms and conditions etc, in r/o Sr. Residents and Jr. Residents (MBBS & Dental) are as under:-

**Minimum Academic/professional Qualification, age limit, emoluments, tenure etc, for the posts of Sr. Residents/Jr. Residents (MBBS & Dental) are as under:-**

**QUALIFICATIONS:-**

**For Sr. Resident:-**

1. The minimum qualification for selection as Sr. Resident in any speciality will be a post-graduate degree or a Diploma in a concerned speciality from recognized university/institution.
2. If candidates having post graduate Degree or a diploma **are not** available in any particular speciality then candidates who have 02 years post MBBS Experience with at least 01 year in concerned Speciality will be considered for the selection.

**For Jr. Resident (MBBS):-**

1. MBBS from recognized university/institution.
2. Internship completion certificate, internship not more than 02 years old as on date of interview i.e on **29.11.2023**. However, the candidate who completed internship more than 02 years old as on date of interview can appear in the interview however they will be offered residency only if no fresh Junior Residents are available.

**For Jr. Resident (Dental):-**

1. BDS degree from recognized university/ institution.
2. Internship completion certificate. Only those candidates will be considered for selection/appointment **who have completed their internship within 02 years on the date of interview (30.11.2023)**. Registration with Delhi Dental Council is compulsory on date of interview. Acknowledgement for registration in DDC will not be accepted.

**AGE LIMIT :-**

**FOR SR. RESIDENTS:** - 45 years as on date of interview as per order No. F.NO. DHF&W/Q015/57/2016-HR-MEDICAL-SECY (H&FW) CD NO.#11245062/1502-08 DATED 26.11.2020. Age limit is relaxable by 05 years for SC/ST candidates and 03 years for OBC (non creamy layer (Delhi only) as per rule.

**For Jr. Residents (MBBS & Dental):** - 30 years for General/EWS category. Age limit is relaxable by 05 years for SC candidates and 03 years for OBC (non creamy layer (Delhi only) as per rule

**Further in case of non-availability of candidates, for the post of Sr. Residents as per the relevant scheme mentioned above, candidates may be considered in terms of the relaxation of provision as per circular No. F.121/26/2010/H&FW/1996/2045 Dated 10.06.2011, issued by H&FW Department, GNCT of Delhi, with the following relaxation.**

**Sr. Residents:-**

1. Senior Residents who have completed Three year of Senior Residency may be allowed to again appear for interview for selection and will be offered residency only if no fresh Senior Residents are available. There would be no extension for any senior resident beyond one year appointed under this relaxed Provision.
2. Separate merit lists for fresh candidate and others (those who have completed 03 years of senior residency already) would be prepared.
3. Firstly, the list containing names of fresh candidates would be exhausted for appointment as senior residents and second list would be used only after that.

**Jr. Resident (MBBS):-**

01. Upper age limit for eligibility will be 40 years in place of exiting 30 years of age.
02. Post graduate Doctors who are interested to serve as Junior Residents will be allowed to join as Junior Residents if fresh graduate are not available.
03. Junior Residents who have completed one year of Junior Residency may be allowed to again appear for interview for selection and will be offered residency only if no fresh junior residents are available. There would be no extension for any junior resident beyond one year of appointment under relaxed provisions.

**TENURE OF RESIDENCY:-**

**For Sr. Residents:-**

**ON ADHOC BASIS:** - initially appointed for a period of 89 days OR till regular appointment is made by the Government under any scheme or proposal, whichever is earlier. In case of no regular appointment of Sr. Residents is made by the government, the tenure can be further extended for a further period of 89 days subject to satisfactory work and conduct/performance **(with one day compulsory break)** time to time for a maximum period of 03 years, including the period served in any Govt.Hospital/Health Institution, if any OR till regular appointment of Sr. Residents is made by the Department/Government under any scheme or proposal, whichever is earlier.

**For Jr. Residents (MBBS & Dental):-**

**ON ADHOC BASIS:** - initially appointed for a period of 89 days OR till regular appointment is made by the Government under any scheme or proposal, whichever is earlier. In case of no regular appointment of Jr. Residents ( MBBS & Dental) is made by the government, the tenure can be further extended for a further period of 89 days, subject to satisfactory work and conduct/performance **(with one day compulsory break)** time to time for a maximum period of One year (which will be counted from the date of joining of the candidate), including the period served in any Govt.Hospital/Health Institution, if any OR till regular appointment of Jr. Resident is made by the Department/Government under any scheme or proposal, whichever is earlier.

**EMOLUMENTS :-**

**For Sr. Residents:** - As per 7<sup>th</sup> CPC pay matrix level 11, Pay Rs. 67700/- plus usual allowances as admissible under the rules.

**For Jr. Residents (MBBS & Dental):-** As per 7<sup>th</sup> CPC pay matrix level 10, Pay Rs. 56100/- plus usual allowances as admissible under the rules.

**Other eligibility norms/General Conditions/Requirements:-**

1. Registration with Delhi Medical Council/Delhi Dental Council is mandatory as on date of interview
2. Candidates applying for the posts of Jr. Resident (Dental) and are registered in other state Dental Council are also allowed to appear in interview. However, in case of selection, the job will be offered only after submission his/her registration in Dental Council within in stipulated period.
3. The posts will be filled up in phases as per availability of vacancies and as per need of the department. The number of vacancies as shown may subject to change in any stage.
4. Appointment shall be subject to medical fitness and verification of educational Certificates, caste certificates from the concerned authorities and submission of Police clearance certificate by the selected candidate.

5. Candidates applied under the OBC category, must have valid OBC certificate with Non-Creamy layer at the time of interview, issued from the Competent Authority of GNCT of Delhi during the current financial year 2023-2024. OBCs certificates with NCL of (1) other states (except Delhi) and (2) not issued during the current financial year (2023-2024) will not be accepted.
6. Candidates applied under EWS category, must have valid EWS certificate, issued from the Competent Authority of GNCT of Delhi during the current financial year 2023-2024. EWS certificates of (1) other states (except Delhi) and (2) not issued during the current financial year (2023-2024) will not be accepted.
7. No TA/DA will be paid for appearing in the interview.
8. In case of non availability of SC, ST, EWS and OBC candidates, the posts shall be filled on adhoc basis for 89 days from other category & vice versa for smooth functioning of patient care service.
9. The selected candidate can be posted in any Jail of Delhi Prisons as per requirement i.e in Tihar, Rohini and Mandoli.
10. Panel of wait listed candidates, 3 times of selected candidates/posts will be prepared and if any vacancies arising in future, the same will be filled from the panel. The Panel shall be valid for one year from date of publication of result of the interview OR till fresh selection process is carried out, whichever is earlier.
11. If any information submitted/provided by the candidate found fake / incorrect at any level, the candidature is liable to be cancelled and necessary action as deemed fit will be taken.

**Registration time:** - 09:30 AM to 11:00 AM on schedule dates.

**Interview Time:** - 10:30 AM onwards on schedule dates.

04. Internship completion certificate (for the posts of Jr. Resident (MBBS & Dental), internship not more than 02 years old from the date of interview.
05. Post graduate Degree/Diploma alongwith mark sheet of each years in case for applying for the posts of Sr. Residents. Experience certificate (s) of at least 02 years out of which one year in concerned speciality.
06. Caste certificate (in case of applying under reserve category) and Non-Creamy Layer certificate, issued during current financial year in case of OBC category Candidates.
07. Attempt Certificate.
08. DMC/DDC registration.
09. Aadhaar card and a proof of permanent address.

**NOTE:** - Only those candidates may appear for interview who fulfill the above criteria and have necessary documents with them. Originals will also be required to be produces at the time of interview.
