**Job Requirements:**

- Experience in CAD software for geometry creation.
- Experience in Thermal and CFD simulation of PVD/CVD Thin film deposition process or crystal growth process.
- Knowledge of theory and practice of CFD and Heat Transfer.
- Understanding principles and related physical/chemical phenomena, including thermodynamics of chemical reactions, heat, and mass transfer.
- Proficiency in using simulation software such as Ansys (Fluent & HFSS) or COMSOL (Multiphysics)

**Job Responsibilities:**

- Should hold the responsibility of simulating the Multiphysics based microwave plasma CVD process concentrating on CFD and thermal aspects of the process using suitable simulation software.
- CAD modeling required for simulation (Solidworks/Creo/Pro-E/CATIA).
- Validating the simulated results using available experimental facility to build an efficient microwave plasma CVD process simulation model.

- Prepare technical documentation, including simulation methodologies, assumptions, and results. Communicate findings to stakeholders, team members, and management in a clear and concise manner.
- Continuously improve knowledge and skills related to heat transfer, fluid dynamics and latest developments in CFD techniques, tools, and methodologies.

### **General Instructions to the candidates**

1. The position is on a contract basis.
2. The completion of the contract period will not confer any right for further extension, regularization, or permanency at the Institute.
3. Candidates should apply online only on the website <https://icandsr.iitm.ac.in/recruitment/>- (Please check the advertisement number Advt.214/2022 displayed and apply for the relevant position).
4. Separate application has to be filled for each post.
5. The system will accept a single application only with the registered login ID (email). For an advertisement, hence the candidate is requested to select the multiple positions (Incase, he/she wishes to apply for more than one position) before the submission of application.
6. The application cannot be edited or reverted once it is submitted.
7. Candidates should not attempt to apply twice for the same post. If multiple applications are received from a candidate for the same position, his/her candidature is liable to be rejected.
8. Candidates should follow the prescribed procedure for the submission of an online application.
9. Candidates are advised to fill in their correct and active e-mail addresses in the online application, as all correspondence will be made by the Institute through e-mail only.
10. The candidates applying for any post should ensure that they fulfil all the eligibility conditions for the post. Their admission to any stage of the selection process will be purely provisional, subject to confirmation that they satisfy the prescribed eligibility conditions. The mere issue of a registration certificate/call letter to the candidate will not imply that their candidature has been found eligible.
11. After successful online submission of the application, a printout of the application form must be obtained and submitted when called for a test. It will be required at the time of document verification/test/interview. A hard copy of the application is NOT to be sent to the Institute.
12. Candidates must be citizens of India. Persons who have migrated from Pakistan with the intention of permanently settling in India or subjects of Nepal are also eligible, but in their case, a certificate of eligibility from the Government of India will be necessary for appointment. Such candidates should apply to the Government of India in the Ministry of Home Affairs for the necessary certificate and furnish satisfactory proof of having so applied.
13. The prescribed qualifications are minimum, and unless specified, they are required for consideration for the post, even if a higher qualification has been acquired and the mere fact that a candidate possesses the same will not

entitle them to be called for an interview.

14. Relevant experience gained after the minimum qualifying degree will only be considered. Minimum requirements of qualifications and experience can be relaxed regarding exceptionally outstanding candidates.
15. The experience required is relaxable at the discretion of the Institute in the case of candidates belonging to the Scheduled Caste / Scheduled Tribe if, at any stage of selection, the competent authority is of the opinion that a sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancy reserved for them.
16. The Institute reserves the right to restrict the number of candidates for written/skill test/interviews to a reasonable limit on the basis of qualifications, level, and relevance of experience higher than the minimum prescribed in the advertisement and other academic achievements. The Institute also reserves the right to reject any or all the applications without assigning any reasons therefore.
17. Calling a candidate for a test/interview merely indicates that it is felt that they with others may be suitable for the post and conveys no assurance whatsoever that they will be recommended or selected or their conditions specified in the application will be accepted.
18. Candidates will be short-listed for Tests/Interview based on their online applications information. They must ensure that such information is true. If at any subsequent stage or at the time of the Test/Interview any information given by them or any claim made by them in their online applications is found to be false, their candidature will be liable to be rejected.
