The Academic score as specified in Appendix II (Table 3A) for Universities shall be considered for short- listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.

The details regarding qualifications, experience, screening guidelines and indicative proforma etc. are available on the site along with the advertisement. The applicants are required to read these details carefully before filling up the form.
- 3. Applicants are required to take 4 sets of print-outs of the Online Application Form filled by them and attach hard copies of the supporting documents (i.e. Educational Qualifications, Employment Experience, Category (if any), NOC (if any), Research Details, Academic Activities etc.) with each print-out as per the Annexures mentioned in the Online Form.
