(ii) Candidate with institutional experience will be preferred.
4.	Age limit	Not more than 50 years as on 24/06/2024 [Monday].
5.	Emoluments	Basic Pay of Rs. 38,029/- + DA admissible (pre-revised) [Consolidated Pay of Rs. 98,400/- per Month]
6.	Date of Interview	24/06/2024 (Monday) [Reporting Time: 08:00 A.M. to 10:00 A.M.]
