- 3. Applications shall be submitted in the format given along with the notification and applications in other formats summarily rejected.
- 4. Sef-attested copies of certificates proving age and educational qualifications for post should be submitted along with the application. Applications without copies of certificates/incorrect/incomplete applications will be summarily rejected.
