- c) Ensuring proper flow of Gypsum, Coal & Flyash during cement mill operation.
- d) Producing quality cement by maintaining proper temperature at cement mill.
- e) Should ready to work in shifts and available for 24 hours in the headquarter.
- f) Should medically fit and submit medical certificate at the time of joining.

- h) Should medically fit and submit medical certificate at the time of joining.

V. <u>Tally Checker (Mechanical- Packing Plant):</u>

- b) Ensuring loading of proper grade of cement as per delivery challan issued by marketing dept.,
- c) Check weighment, cross checking/ counting of loaded trucks/ wagons

- e) Co-ordination of shifting of proper grade and quantity of cement empty bags from godown
- f) Ensuring timely loading of vehicles/ wagons

VIII. Junior Engineer (Instrumentation Department):
