Engagement of Research Associates in VECC, Kolkata

VECC is inviting applications from Indian nationals for filling up **SEVEN (7) Research Associate (RA)** positions in the specialized areas given below for working under the supervision of faculty at VECC, Kolkata. The RA will have access to the research infrastructure facilities available at VECC with due permissions.

1. Eligibility:

Candidates with provisional PhD certificate can apply for the Research Associate position (RA-1).

2. Fellowship:

The fellowship given by VECC will be as per DAE guidelines. The Fellowship for Research Associates are as follows:

- Rs.58,000/- per month for RA-1;
- Rs.61,000/- per month for RA-2;
- Rs.67,000/- per month for RA-3.

Research Associate will be eligible for annual contingency of Rs.60,000/- per year and follow the DAE guidelines for utilization of the grant.

Notes:

The Research Associates will be placed at one of the 3 fellowships (RA-1, RA-2, RA-3) as indicated above depending on the following criteria as decided by the Selection Committee.

- i) Performance in the selection interview.
- ii) Post-Ph.D. research experience (if any) as evident from the publications and/or products/processes designed and/or developed.

The fellowship is tenable for **ONE** (1) year in the first instance and extendable up to a maximum of **THREE** (3) years after performance reviews at any time recommended by a duly appointed committee and also depending upon availability of position. In addition to the fellowship, HRA is permissible at the rates of the fellowship guidelines of DAE. HRA is not admissible, in case VECC provides accommodation.

4. Selection Procedure

The short-listed candidates will be interviewed for final selection before the placement as Research Associate. Selection Interview will be held at VECC in **OFFLINE/ONLINE** mode based on the request of the applicant.

8. Checklist for submission of application

Before submission of application in the prescribed format, you need to have the following data ready (in JPEG/ PDF formats) for uploading:

- A passport size photo (in JPEG format, less than 1 MB Size).
- Birth Certificate/10th pass certificate in support of date of birth.
- PhD degree Certificate Provisional/Regular.
- List of publications.
- A write up within 500 words highlighting plan of work at VECC.
- Recommendation letter (at least 1).

9. General Information and broad guidelines

- Applications are to be made via e-mail (ra2024@vecc.gov.in) only.
- The selected candidates do not confer any right to claim for any employment in this Centre or any other unit of the Department of Atomic Energy on the basis of the present selection.
- The qualification prescribed should have been obtained from recognized Universities / Institutions.
- The candidature of the applicant shall remain provisional till detailed scrutiny of his/her documents are undertaken. In the case of any dispute, the decision of VECC shall be final in deciding the eligibility of the candidate. The mere fact that a call letter has been issued to the candidate and he/she is allowed to appear in the interview will not imply that entries made by the candidate in his/her application have been accepted as true and correct. VECC would be at liberty to reject any application at any stage of the selection process if the candidate is found ineligible or if it comes to the notice that the candidate has furnished false information.

- All information related to the selection will be made available on the website i.e. http://www.vecc.gov.in. Candidates are advised to visit the website regularly for information and updates in this regard. Information displayed on the website will be deemed as intimation to the candidates.
- Interview will be held either in offline or in online mode (as requested by the candidate). If candidates are called for physical interview, they will be paid to and fro fare to the extent of second-class sleeper railway fare (Travelling Allowance) by the shortest route as per rules. However, Travelling Allowance is not admissible to those candidates who are already serving in Central/State Government, Central/State Government Corporation, Public Sector Undertakings, Local Government Institutions and the concession availed from Railways, if any, for undertaking journey for attending the Interview. They have to produce tickets and other relevant documents (if required) in support of their claim. TA claims will be credited to their savings bank account only if it is found in order as per extant rules.
- Any legal disputes arising out of this notification are subject to Kolkata jurisdiction only.
- Corrigendum/Addendum, if any, pertaining to this advertisement will be uploaded only on VECC website.
