- 2. In addition to the emoluments indicated against each category of posts, benefits such as reimbursement of Medical Expenses, Leave Travel Concession and Children's Education Allowances etc. are also available as per CSIR/Govt. of India (GoI) Rules as applicable to the Council Servants.
- 3. The selected candidates will be governed by the 'National Pension System' or Extent Pension System based on defined contributions as adopted by CSIR for its employees.
- 4. CSIR provides excellent opportunities to deserving candidates for career advancement under Assessment Promotion Scheme for Scientists, as per rules as amended from time to time.
- 5. Deserving candidates may be considered for advance increments based on recommendations of the Selection Committee, subject to acceptance by the Competent Authority, in accordance with the provisions outlined in the CSIR Recruitment and Promotion Rules.
- 6. - f. The screening and selection of candidates will be conducted on the basis of the documents and information provided in the online application only.
