
1. The details/ eligibility of engagement are as under:-

1.	Designation	Pay Level-2, Level-6 & Level-7
2.	Powers to re-engage retired staff	General Manager/RCF.
3.	Eligibility	Retired Railway Staff, who have retired from Pay Level-2, Level-6 & Level-7
4.	Period of engagement	The offer is initially for 01 year or till further order, whichever is earlier.
5.	Place of posting	Rail Coach Factory/ Kapurthala
6.	Age Limit	Must be below 64 years as on date 31.03.2025. Maximum age limit for which re-engagement shall continue will be 65 years.
7.	Application to be forwarded to	APO-I/RCF/KXH

- No. of vacancies may increase/decrease depending upon the requirement of administration.
- A fixed monthly amount shall be admissible as remuneration during the contract period, arrived at by deducting the Basic pension from the Pay drawn at the time of retirement. The amount of remuneration so fixed will remain unchanged during the term of the contract. Annual increment/percentage increase and Dearness Allowance shall not be allowed during the contract period. [Example for determining remuneration shall be as given in DoE's OM No. F.No.3-25/2020-E.IIIA, Dated 09.12.2020].
- Period of engagement shall be initially for ONE year and further extendable as per requirement.
- Must be below 64 years as on date 31.03.2025. Maximum age limit for which re-engagement shall continue will be 65 years.

6. Decision of the RCF administration for re-engagement of retired staff will be final.
7. While re-engaging such staff, medical fitness of the appropriate category will be obtained from the designated authorities as per existing practices.
8. Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond calendar year will not be allowed, nor carried forward in case the Engagement is extended. Also, no payment in lieu of unutilized leaves will be paid at the time of discharge / expiry of contract.
9. Re-engaged staff will not be entitled for increment, dearness allowance, HRA, Residential accommodation. However, Transport Allowance for the purpose of commuting between the residence and the place of work will be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed will remain unchanged during the term of contract. Retired staff re-engaged on the contract basis will be allowed DA/TA if perform outstation duty in official hours, if any, as per their original entitlement while in service availed by them on the last day of superannuation.
10. Designation and duties of re-engaged shall be decided by RCF administration.
11. GM (P) , RCF is authorized to execute contract agreement on behalf of RCF administration after acceptance of offer of engagement on the contract basis. The contract agreement shall be executed on Non-Judicial stamp paper of Rs. 100/- value & duly notarized & registered with notary.
12. The retired employee seeking re-engagement should be free from D&AR and Vigilance cases on date of signing of the contract agreement.
13. For the purpose of re-engagement, APARs for the last five years will be taken in to consideration.
14. Retired employees being re-engaged should not have been covered under the safety related Retirement scheme/Liberalized Active Retirement scheme for Guaranteed Employment for safety staff (LARSGESS).
15. Duty list of re-engaged staff will be issued after signing of Contract agreement by the re-engaged employee.
16. Re-engaged staff shall be discharged immediately on joining of selected candidates from RRBs and from other sources .
17. Re-engaged staff shall not be made in charge of the Section/Unit in the PU's/Division/Zonal Railways . Re-engaged staff shall not be given the financial and D&AR powers and shall not be authorized to issue any safety certificate . Re-engaged staff may recommend their suggestions and other matters to regular or in-service staff/officer.
