- Candidates applying for the posts should apply online through the web link <https://services.niot.res.in/Recruit>. They must download the filled application form generated online and produce it at the time of registration for the interview/test on the scheduled dates as follows:

- The Interview/Written test for the posts will be held at National Institute of Ocean Technology, NIOT Campus, Velachery-Tambaram Main Road, Pallikaranai, Chennai – 600100, Chennai TN.

4. If original certificates are not produced or discrepancies are found in the certificates, the supporting documents or concealing of facts are noticed, the candidature will be summarily disqualified and rejected.
5. The candidate must read the instructions thoroughly before the filling the application forms. All details furnished in the online application will be treated as final, and no changes will be made later.
6. If the number of applicants is very large, the selection committee may conduct a screening test for the candidates appearing for the interview on the scheduled date mentioned above, in order to restrict the number of candidates to a manageable and reasonable level. In such cases, the interview will be conducted either on the same day or on the following day. Candidates are advised to take note of this possibility and make arrangements for their accommodation and travel accordingly.
7. Candidates are requested to visit the NIOT website periodically to stay informed about new announcements and any changes.
8. Candidates who face any technical problems while applying for the online application form may send their queries to the e-mail address [sysadmin@niot.res.in](mailto:sysadmin@niot.res.in) indicating the problem faced alongwith the screen shot.
9. The candidate has to fill the application online and upload recent passport size colour photograph and scanned copies of the documents listed below:-
  - (i) Educational Qualification Certificates from 10th Standard onwards.
  - (ii) Mark List & Degree Certificate.
  - (iii) Experience certificates issued by the Employer.
  - (iv) Certificate in prescribed format (in respect of candidates claiming age relaxation under Ex-serviceman/ PwD Category).
10. The candidate has to submit their profile upon which a registration number will be generated. The applicant has to apply for the Post desired by selecting the same. On submitting the completed application, an online application Number will be provided by the system for the post applied. The candidates must download the copy of the application generated which will contain both registration number and application number for each post applied for. Candidate without application number will not be permitted to attend the selection process.
11. Request for change/correction in the Application Form will not be entertained under any circumstance. Therefore, the candidate must ensure the accuracy of the data entered and the documents uploaded.
12. Incomplete applications without uploading the required documents, photographs etc will be treated as invalid and rejected.

## **Terms and Conditions**

1. The candidate must be a CITIZEN OF INDIA.
2. The candidate must ensure that he/she is eligible in all respect for that post for which he/she is applying and must fulfill all the eligibility criteria specified in the advertisement and if it is found not-eligible in any aspect at any stage, his/her candidature will be summarily rejected and cancelled without further correspondence.
3. The applicant should produce the original certificates uploaded in the on-line application at the time of interview/Joining. If original certificates are not produced or discrepancies are found in the certificates, the supporting documents or concealing of facts are noticed, the candidature will be summarily disqualified and rejected.
4. The Crucial Date for determining the possession of 'AGE AND ESSENTIAL QUALIFICATION (EQs)/EXPERIENCE' will be the closing date for on line application. The applicants should not have exceeded the maximum age limit on the crucial date. The Date of Birth as recorded in the 10thStd/Matriculation/Transfer certificate/Certificate of Domicile/Birth Certificate issued by the competent authority will be accepted as proof of age. Only post-qualification experience is to be counted for all the posts.
5. The upper age limit in respect of Ex-servicemen/ PwD categories shall be relaxable in accordance with the orders issued by the Central Govt. from time to time in this regard.
6. The candidates seeking age relaxation must upload the required certificate in the prescribed format duly signed by the issuing authority at the time of submission of online application.
7. The prescribed educational qualifications are the minimum and mere possession of the education qualifications and requisite experience will not entitle any right to be called for interview/ written test.
8. Applicant should ensure that he/she possess essential educational qualification and the experience in the relevant area as required for the post.
9. In case, the particular University/ Institute does not follow percentage system for awarding marks, the percentage arrived will be taken as per conversion formula mentioned in the certificate of marks. In case where conversion formula is not available, the percentage will be reckoned by multiplying the CGPA \* 9.5.
10. Experience claimed by the candidate will be counted only from the date on which the candidate has acquired the minimum educational qualification required for the post. Doctorate Degree in the relevant area of research will count as 3 years' experience for Scientific Posts. In case of concurrent employment while undertaking research, no addition experience will be counted for PhD.
11. The candidates will be required to participate in scientific cruises, field visits, survey etc in ships, boats.
12. NIOT strives to have gender balance and Women candidates fulfilling the requirements are encouraged to apply for the post.
13. Candidates who are employed in Government/ autonomous Institutions and PSU should submit NOC from the employer at the time of interview.
14. No TA/DA will be paid for attending the Interview / Written Test.

15. The posts advertised are temporary in nature and the appointment will be contract basis for fixed tenure which is co-terminus with the project. The completion of tenure of contract will not confer right for regularization or permanency in NIOT.
