**DIRECT RECRUITMENT FOR FILLING UP OF THE VACANT POST OF  
JUNIOR ENGINEER (ELECTRICAL) IN ELECTRICITY DEPARTMENT**

Applications are invited from the eligible Indian Citizens who are Natives/Residents of the Union Territory of Puducherry for Competitive Examination to be held for Direct Recruitment to the post of **Junior Engineer (Electrical) amalgamated post of erstwhile Junior Engineer Grade-II** (Group 'B' Technical, Non-Gazetted) in the Electricity Department, Puducherry on regular basis as detailed below:-

- (i) The vacancies notified are existing vacancies. However, the Government reserves the right either to enhance or to reduce the number of vacancies notified depending upon the actual requirement at the time of selection and also to cancel the recruitment process on administrative reasons. No interim enquiry will be entertained.
- (ii) Reservation and concessions for eligible categories shall be extended as per rules in force.
- (iii) The candidates finally selected for appointment are liable to be posted in any of the regions of UT of Puducherry.
- (iv) Persons with Benchmark Disability (PwBD) as defined for the post of Junior Engineer (Electrical).

### 1. EDUCATIONAL QUALIFICATION:

#### Desirable:

A Degree in Electrical Engineering of a recognized University or A.M.I.E. (Electrical)

#### Note:

1. A Degree in Electrical and Electronics Engineering of a recognized University will be considered as equivalent to Degree in Electrical Engineering.
2. The candidates who were enrolled for Associate Member of Institution of Engineers in Electrical Engineer (AMIE) up to 31-05-2013 are only eligible for consideration to the post of Junior Engineer (Electrical) for direct recruitment and candidates who have enrolled on or after 01-06-2013 for AMIE are not eligible for consideration to the post of Junior Engineer [(Electrical) (Direct Recruitment)].

#### Essential:

Diploma in Electrical Engineering or Diploma in Electrical and Electronics Engineering or its equivalent Diploma in a recognised institution / Technical Board with 3 years of experience after acquiring Diploma.

#### Note:

The 3 years of experience should have been acquired in the relevant electrical field from a reputed industry/utility. The validity and veracity of the experience certificate will be got verified by the Government and the decision of the Government shall be final in this regard.

### 3. AGE LIMIT

Not exceeding 30 years as on **31.03.2025**, the last date for applying through online. Age limit is relaxable for applicants belonging to the categories of OBC/MBC/BCM/EBC/SC/ST/Ex-Servicemen/PwBD/In-service applicant as detailed below:-

**DURING CERTIFICATE VERIFICATION**

**4. NATIVITY/RESIDENCE CERTIFICATE :**

Those who are native of Union Territory of Puducherry or who have continuous residence in the Union Territory for the last 5 years immediately preceding the closure date of notification only are eligible to apply for the posts. The applicants on selection should furnish the **Nativity/Residence Certificate** issued by an Officer of the Department of Revenue and Disaster Management not below the rank of **Deputy Tahsildar, at the time of certificate verification.**

**5. COMMUNITY CERTIFICATE :**

The selected applicants belonging to **OBC/MBC/BCM/EBC/SC and ST categories** should produce fresh Community Certificate obtained in the prescribed form issued by an Officer of the Department of Revenue and Disaster Management not below the rank of **Deputy Tahsildar, at the time of certificate verification.**

**Applicants applying under SC quota should furnish Community Certificate issued under**

**“The Constitution (Pondicherry) Scheduled Castes Order, 1964” (or) in respect of “Puthirai Vannan” The Constitution (Scheduled Castes) Orders (Second Amendment) Act, 2002”**

Applicants applying under ST quota should furnish community certificate issued under **“The Constitution (Puducherry) Scheduled Tribes Order 2016”**.

Candidates found to produce fake/ manipulated Community Certificate will be terminated (if selected provisionally) immediately and penalized as per rules.

**6. CERTIFICATE FOR EWS CANDIDATE:**

The Candidates selected under EWS category should submit Income and Asset Certificate obtained in the prescribed form issued by an Officer of the Department of Revenue and Disaster Management not below the rank of Deputy Tahsildar, **at the time of certificate verification** as per **O.M. No. 36039/1/2019-Estt (Res), dt.31.01.2019 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training.** The crucial date for submitting income and asset certificate by the candidate will be the closing date for submission of online application ie **31.03.2025**. The certificate should have been issued for the financial year 2023 -2024 and shall be valid for the year 2024-2025.

Candidates found to produce fake/ manipulated Income & Asset Certificate will be terminated (if selected provisionally) immediately and penalized as per rules.

**6. PERSONS WITH BENCHMARK DISABILITY (PwBD):**

- 6.1. To claim reservation under the Persons with Benchmark Disability (PwBD) category, the percentage of relevant disability as assessed by the Medical Board, Government of Puducherry should be not less than 40%.
- 6.2. The applicants who apply against the horizontal reservation provided for Persons with Benchmark Disability (PwBD), on selection should necessarily submit fresh Medical Certificate issued by District Medical Board, Government of Puducherry at the time of certificate verification.
- 6.3. The Certificate should have been issued within three years before the closing date of application through on-line for this recruitment.
- 6.4. Certificate issued by any other authority will not be accepted.
- 6.5. The categories of disability suitable for the post are detailed in Part-II of General Instructions to candidates.
- 6.6. **Provision of Compensatory Time and assistance of scribe:**
  - 6.6.1. In case of persons with benchmark disabilities in the category of cerebral palsy, the facility of scribe is provided, if opted by the candidate in their online application.

- 6.6.2. The facility of scribes will be provided to the PwBD candidates only if he/she has opted for the same in the online application form.
- 6.6.3. In case of remaining categories of persons with benchmark disabilities, scribe will be provided on production of a certificate at the time of examination to the effect that the person concerned has physical limitation to write, and scribe is essential to write examination on his behalf, from the Chief Medical Officer/ Civil Surgeon/ Medical Superintendent of a Government health care institution as per Proforma at Part-III of this Notification.
- 6.6.4. The Persons with Benchmark Disability belonging to categories other than cerebral palsy has to submit their request letter for scribe along with required certificate as mentioned above to the Examination Cell, DP&AR, Chief Secretariat, Puducherry one week before the date of conduct of exam. Last minute request will not be entertained.
- 6.6.5. Arrangement of own scribe will not be permitted. Official scribe will be provided by the Examination Cell, DP&AR, Chief Secretariat, Puducherry.
- 6.6.6. A compensatory time of 20 minutes per hour of examination will be provided to the persons who are allowed use of scribe as described above.
- 6.6.7. The candidates referred at above who are eligible for use of scribe but not availing the facility of scribe will also be given compensatory time of 20 minutes per hour of examination.
- 6.6.8. No attendant other than the scribe for eligible candidates will be allowed inside the Examination Hall.
- 6.6.9. The PwBD candidates who have availed the facility of scribes and/ or compensatory time must produce relevant documents for the eligibility of scribe/ compensatory time at the time of Certificate Verification. Failure to produce such supporting documents will lead to cancellation of their candidature for the examination.

## **7. EX-SERVICEMEN:**

### **7.1 Explanation:** An 'ex-serviceman' means a person:

- (a) Who has served in any rank whether as a combatant or non-combatant in the regular Army, Navy and Air Force of the Indian Union, and
  - (i) Who either has been retired or relieved or discharged from such service whether at his own request or being relieved by the employer after earning his pension;  
or
  - (ii) Who has been relieved from such service on medical grounds attributable to military service or circumstances beyond his control and awarded medical or other disability pension;  
or
  - (iii) Who has been released from such service as a result of reduction in establishment;
- (b) Who has been released from such service after completing the specific period of engagement, otherwise than at his own request, or by way of dismissal, or discharge on account of misconduct or inefficiency and has been given a gratuity; and includes personnel of the Territorial Army, namely, pension holders for continuous embodied service or broken spells of qualifying service;  
or
- (c) Personnel of the Army Postal Service who are part of Regular Army and retired from the Army Postal Service without reversion to their parent service with pension, or are released from the Army Postal service on medical grounds attributable to or aggravated by military service or 8 circumstance beyond their control and awarded medical or other disability pension;  
or

- (d) Personnel, who were on deputation in Army Postal Service for more than six months prior to the 14th April, 1987;  
or
- (e) Gallantry award winners of the Armed forces including personnel of Territorial Army;  
or
- (f) Ex-recruits boarded out or relieved on medical ground and granted medical disability pension.

**7.2** The applicants who apply under Ex-Servicemen category should necessarily submit the Discharge Certificate & particulars of Registration with the Department of Sainik Welfare, Puducherry.

**7.3** **Age relaxation is not admissible to sons, daughters and dependents of Ex-Servicemen. Therefore, such candidates should not indicate their category as Ex-Servicemen.**

**8. MODE OF RECRUITMENT/PATTERN OF EXAMINATION :**

**a) Written Examination:**

The vacancies in the above said posts will be filled through a Written Competitive Examination. The Question paper will be of objective type consisting of two papers (Paper-I and Paper-II) with 100 marks each in forenoon and afternoon sessions with duration of 2 hours having 100 questions carrying one mark each. The Question paper will be in **English** only.

Note: All the questions will be set in SI units.

**Weightage of marks**

- (i) 25% Weightage will be given for Paper-I
- (ii) 75% Weightage will be given for Paper-II

**Negative mark of 0.25 will be awarded for every wrong answer** and multiple answers will be treated as a wrong answer.

Answering would be in the form of shading the correct answer by using **black ball point pen only** and the applicants are permitted to take the carbon copy of their answer sheets along with their question booklet.

The answer key will be published in the recruitment website <https://recruitment.py.gov.in> after completion of examination process.

**(b) Selection procedure**

**(i) Minimum qualifying marks prescribed for the written examination:**

A list of candidates will be provisionally shortlisted from the merit list based on the marks obtained by the applicants in the written examination subject to reservation as per the rules in force. Overall minimum qualifying to be secured by the various category of candidates are as follows:

**Minimum qualifying marks:**

The candidates shall secure minimum qualifying percentage of marks in the Written Competitive exam as follows:

Unreserved	-	30%
MBC/OBC/EWS/EBC/BCM	-	25%
SC/ST/PwBD	-	20%

A candidate must appear in both the Paper – I and Paper-II to become eligible to be included in the merit list subject to obtaining of minimum qualifying mark prescribed above in each paper (Paper – I and Paper-II) and thereafter, weightage will be given as mentioned at 8(a) above.

The Government reserves the right to relax the qualifying marks in exceptional circumstances

**(ii) Mode of Selection:**

Merit list will be prepared on the basis of the performance of candidates in the Written Competitive Examination. Final selection of candidates, in each category will be made on the basis of marks scored by them in the Written Competitive Examination, irrespective of the possession of Essential / Desirable qualification.

**Note:**

The validity of operation of wait list, if drawn, will be two years from the date of declaration of the results/publication of select list. The wait list will be operated in the event of occurrence of vacancy caused in the select list due to rejection of candidature, for non-production of required certificates, non-appearance of candidate for certificate verification, non-joining of candidate within stipulated time allowed for joining the post or when a candidate joins but resigns or dies within a period of one year from the date of joining.

**(c) Resolution of Tie Cases:**

In the event of tie in scores of candidates in the examination, merit will be decided by applying following criteria, one after another in the given order, till the tie is resolved:

- (i) Date of birth, with older candidate placed higher
- (ii) Alphabetical order in which the names of the candidates appear.

## 9. DATE AND VENUE OF EXAMINATION:

The Written Competitive Examination will be held only in the **Puducherry** region of Union Territory of Puducherry. The exact date, time and venue of the examination will be intimated in due course in the Recruitment website, Electricity Department website, and also in leading newspapers.

## 10. HOW TO APPLY AND LAST DATE FOR APPLICATION:

The application fulfilling the eligibility criteria as mentioned above may apply online only through official website <https://recruitment.py.gov.in> from **12.03.2025** (10.00 A.M) to **31.03.2025** (03.00 P.M.)

The Diploma holders have to submit the hard copy of online application along with self-attested photocopies of the Diploma certificate and Experience Certificate to the "**O/o. of the Superintending Engineer-cum-HoD, Electricity Department, No.137, N.S.C. Bose Road, Puducherry – 605001**" on or before 3.00 PM of **08.04.2025**. The application should be sent in an envelope superscribed as "**APPLICATION FOR THE POST OF JUNIOR ENGINEER (ELECTRICAL)**". This Department shall not be responsible for any postal delay. **The candidature of the Diploma holders who have not submitted the hard copy of the online application along with the Diploma Certificate and Experience Certificate within the due date and time of 3.00 PM on 08.04.2025 will be summarily rejected.**

## 11. SUBMISSION OF ONLINE APPLICATION:

- 11.1. The applicants have to register with their Mobile Number in the online portal "<https://recruitment.py.gov.in>" for applying through online.
- 11.2. They will receive Username and Password through SMS in the mobile number provided. The applicants may login the online portal using the Username and Password and apply for the post.
- 11.3. The applicants are advised to change the default Password received in their mobile after first login.
- 11.4. It is the applicant's responsibility to maintain the secrecy of the password and it should not be disclosed to anyone.
- 11.5. The applicants may view, print & check the status of their application and download the Hall Ticket by logging in the online portal using the username and password. Hence, they are advised to keep the user name and password safe for future reference until the recruitment process is over.
- 11.6. **Photograph & signature uploading:**
  - 11.6.1. Applicants shall upload their Photograph and Signature using either option 1 (or) option 2 provided in the recruitment portal as given below:-
  - 11.6.2. Option 1 (Scanned Photograph and Signature as a single image)
  - 11.6.3. Applicants are instructed to scan their recent passport size colour photograph & signature in an A4 sheet with 200 DPI resolution, dimensions should be minimum of 600 x 600 pixel and the file size should be less than 150KB. (as shown in guidelines video for uploading and cropping your photograph and signature during online application)
  - 11.6.4. Option 2 (Scanned Photograph and Signature as separate images)  
Applicants are instructed to scan their Photograph in JPEG format with 238 x 306 pixel dimension and the file size should be less than 50KB. Signature file format should be JPEG, dimensions should be 350 x 150 pixel and file size should be less than 30KB.
  - 11.6.5. The photograph should have been taken recently, preferably within three months.
  - 11.6.6. Read / View the Photograph & Signature (Text / Video) guidelines in the instruction page of online portal <https://recruitment.py.gov.in> for guidance.

- 11.7. **PREVIEW** facility is available to view the details entered and please verify it before submitting the application.
- 11.8. After checking the information provided, Click **SUBMIT** button without fail.
- 11.9. If the applicant fails to submit the application by clicking **SUBMIT** button after **PREVIEW**, the application will remain in **PREVIEW** stage only and it will not be considered as a valid application and it will be rejected, for which the Government will not be responsible.
- 11.10. Candidates whose application remains in **PREVIEW** stage will not be allowed to write the examination.
- 11.11. Even after submission of application, corrections, if any, can be done before the closing date.
- 11.12. Keep a copy of the online generated application for your future reference.
- 11.13. Please logout / sign out after submission of application.
- 11.14. Online generated applications can be viewed in any standard PDF readers.
- 11.15. Please use latest web browser for better compatibility, better user experience and improved security.
- 11.16. Candidates are advised to submit online applications much before the closing date and not to wait till the last date to avoid the possibility of disconnection/ inability or failure to login to this website on account of heavy load during the closing days.
- 11.17. The Department does not accept any responsibility for the candidates not being able to submit their applications within the last date on account of the aforesaid reasons or for any other reason beyond the control of the Department.
- 11.18. Application with incomplete data / information and improper photograph and signature is liable for rejection.
- 11.19. The information / data furnished by the applicants in the online application are final and cannot be altered after the closure of the application on **31.03.2025** (03.00 P.M.)
- 11.20. Requests for change of date of birth, category, etc. will not be entertained on any account at a later date.

## 12. PROCEDURE FOR IN-SERVICE APPLICANTS:

- 12.1. The candidates working in the line of promotion in Electricity Department, Puducherry and allied cadres under various Departments in the Government of Puducherry will be allowed to appear as in-service candidates by availing the permissible age relaxation mentioned in the statement under "Age Limit" of this notification.
- 12.2. The In-Service applicants should have completed three years of regular service to avail age relaxation.
- 12.3. Applicants working in Government Department/Offices and applying as in-service applicants availing the age concessions should forward the copy of the online generated application through their respective Head of Office/Department within the due date i.e. on or before 3.00 P.M. on **08.04.2025** to "**The Superintending Engineer-cum-HoD, Electricity Department, No.137, N.S.C. Bose Road, Puducherry - 605 001**". The applications of in-service candidates which are not duly forwarded by the Head of Office/Department within the due date and time of 3.00 P.M on **08.04.2025** will be summarily rejected. Transit delay will not be entertained. Advance copy of the online application for in-service candidates will not be entertained.
- 12.4. Other applicants who are working in the Government Departments/ Offices who are within the age limit and applying as open candidates may intimate the fact of submission of application to the post of **Junior Engineer (Electrical)** to their Head of Departments / Offices, so as to have the benefit of "Technical Resignation" on selection to the post of **Junior Engineer (Electrical)** in the written examination.



## GENERAL INSTRUCTIONS TO CANDIDATES

### PART-I

Applicants should read the following instructions carefully before applying:

1. Mode of applying for the Competitive Examination for Direct Recruitment to the post of **Junior Engineer (Electrical)** is **only through online**. Avoid registering multiple online applications and register only one single application. In case of multiple online applications, only the latest application will be accepted and all other duplicate applications will be rejected.
2. All candidates who register themselves in response to this advertisement by the closing date and time and whose applications are found to be in order will be provisionally accepted as per the terms and conditions of this Notice of Examination.
3. Candidates must go through the requirements of educational qualification, experience, age, etc. and satisfy themselves that they are eligible for the post.
4. The Department will not undertake any detailed scrutiny of applications to check eligibility and other aspects at the time of written examination and, therefore, admission to the examination will be provisional only, which will not confer any right on such provisionally admitted candidates to claim appointment based on such provisional admission.
5. Candidates are cautioned that they must ensure that they belong to the category as filled in the application form and are able to prove the same by furnishing the requisite certificate from the competent authority when such certificates are sought by this Department at the time of certificate verification, failing which their candidature will be cancelled. For example, candidate X filled OBC in his application form. However, during certificate verification, he is unable to produce the valid OBC certificate. In such scenario, candidature of X will be cancelled.
6. The Candidates who mention their category as MBC-Migrant / OBC-Migrant / BCM-Migrant / EBC-Migrant / SC-others/ST -Migrant in their online application will be considered only under unreserved category.
7. The certificates/documents in support of their educational qualifications and caste/category, etc. shall be sought from the provisionally selected candidates at the time of Certificate Verification only. After verification of the certificates/ documents of educational qualifications/ caste/ category, etc., if any claim made in the application is not substantiated by certificates/ documents, the candidature of candidate will be cancelled/rejected, without any notice.
8. All the communications with regard to this recruitment will be published in the Website <https://recruitment.py.gov.in>. Applicants are advised to visit the website and watch the news in dailies regularly for information. They are advised to keep the Mobile number given in the online application active for sending SMS connected with this recruitment.
9. **Change of Address and Mobile number, if any, after submission of application should invariably be intimated to the Department by Registered Post with Acknowledgement Due.** Otherwise the Department will not be responsible for any delay/ non-delivery of letters / SMS messages.
10. If candidates are found to indulge at any stage in any of the malpractices, their candidature or this examination will be cancelled and they will be debarred from the Government examinations in future for a period as may be decided by the Government.
11. The decision of the Government as to the eligibility or otherwise of the applicant for admission to the Examination shall be final.



12. A separate press note will be issued in leading regional news dailies regarding the issue of hall tickets through online. The eligible applicants can download their Hall Ticket from the Website <https://recruitment.py.gov.in> by using the "User Name and Password".
13. The applicant, after applying can also make corrections in their on-line application, if any error occurred while entering the data. They are allowed to avail this facility till 3.00 p.m. on **31.03.2025**.
14. The information/data furnished by the applicants in the online application are final and cannot be altered after the last date of applying i.e. **31.03.2025**.
15. Before submission of the applications / corrected applications, candidates must check that they have filled correct details in each field of the online form. After the closing date for receipt of online application i.e **31.03.2025**, no change / correction / modification will be allowed under any circumstances. Requests received in this regard in any form like Post, Fax, E-mail, by hand etc. will not be entertained by this Department and will be summarily rejected.

17. Applicants except In-Service candidates / Diploma holders need not send the printout of the online application or any other supporting documents to this Department.
