- <u>Age</u>: Not exceeding 69 years as on last date of receipt of application.(Age Relaxation for SC/ST/OBC and all others as per Central Government Rule).
- **Exam Fee** : For General & OBC candidates fee is Rs 300/- in the form of Demand Draft' in favour of 'ESI Model Hospital A/C 2' payable at 'Rourkela'. There is no fee for SC/ST/women & PWD Candidates.

Tenure of Contract:

- 1) For FTS One year on contract or till regular incumbent joins, whichever is earlier. The Contract will be extendable for a further period of 02(Two) more years based on satisfactory performance.
- 2) For PTS One year on contract from the date of joining or till regular incumbent joins, whichever is earlier.

Qualification: MBBS with PG Degree or equivalent / PG Diploma in concerned speciality from recognized university and registered with Medical Council of India/ State Medical Councils.

Experience: PG Degree with 3 years experience or PG Diploma with 5 years experience in respective speciality after PG.

Consolidated remuneration:

- 1) Full Time Specialist: Rs 1,06,000/- (Rupees One lakh six thousand) only per month.
- 2) Part Time Specialist: Rs 60,000/- (Rupees Sixty thousand) only per month.
 - a) Charges for Emergency visit, if willing: Rs 15,000/- would be payable in case of attending emergency call beyond duty hour whenever need arise. The payment of remuneration will be guided by existing Hqrs. Instruction dated 13.04.2022 or any amendment from ESIC Hqrs. Office from time to time

Duties:

- 1) <u>Full Time Specialist</u>: Working hours: 9:00 AM to 04:00 PM on week days and 09:00 Am to 01:00 PM on Saturdays. Should make emergency visit as and when it is required.
- 2) **Part Time Specialist**: Working hours: 04 hours a day for 04 days in a week.

The candidate applying to the post of Full Time Specialist / Part Time Specialist shall apply the application form under **Annexure-B**. The date of Interview shall be communicated to the applicant after scrutiny of application. The candidate shall bring the following documents with them on date of interview.

Terms & Conditions:

 The appointment will be contractual basis and initially for a period of one year or till the joining of regular incumbent (Whichever is earlier) in ESIC Model hospital, Rourkela. However, the engagement can be extended beyond the period of one year if vacancy exists and if the performance is found satisfactory. The engagement can also be short closed before one year if the performance is not found satisfactory or if the vacancy ceases to exist.

- 2. Vacancies are likely to change depending upon actual requirement at the time of interview.
- 3. In case of serving candidate, No Objection Certificate (NOC) from the present employer shall be produced at the time of interview.
- 4. No TA / DA will be paid to candidates for appearing in the interview.
- 5. The Medical Superintendent reserves the right to fill up all or any of the vacancy / post.
- 6. The Medical Superintendent reserves the right to alter the date or cancel the interview without assigning any reason thereof.
- The selected candidates shall have to join duty immediately or the date indicated in the offer of appointment.
- 8. Full Time Specialists are not allowed of any private practice during the working hour at ESIC Model Hospital, Rourkela.
- 9. Hostel Accommodation / quarters will not be provided.
