Prayas is a field action project of the Centre for Criminology and Justice, School of Social Work, initiated in 1990. It is a response to the needs of disadvantaged groups being processed by the Criminal Justice System. It aims at socio-legal and economic rehabilitation of persons who are at risk of being criminalized, exploited for commercial sex, and those in destitute states.

Prayas invites interested candidates to apply for the post of One (1) Legal Fellow (Male) for Kolhapur District and One (1) Legal Fellow (Female) for Thane District (on contract for one year)

#### **Qualification and Experience:**

- LLB degree
- Sanad for practicing in Maharashtra
- Field experience in legal aid and criminal justice is desirable.
- Ability to read, write and speak in Marathi, English Hindi.
- Familiarity with the use of MS-Office, Excel, emails and the internet.
- Preference may be given to lawyers with 2-3 years of legal practice.
- Ability to work effectively in teams as well as independently.
- During contract period, Fellow shall not take up any other employment without the prior permission of the employer.

#### **Key Responsibilities:**

- Access to legal aid (District Courts and for High Court for bail matters)
- Assess and support appeal matters of convict prisoners.
- Coordinate with High Court Legal Services Committee, DLSA, Legal Aid Defense Counsels, Legal Aid Panel lawyers, and Prison Authorities.
- Support post-release reintegration through referrals.

- The Institute reserves the right to relax qualification and working conditions of the candidate based on the work experience and to relax age in the case of persons already holding comparable positions in a University/Research Institution of repute.
