- h) "No Objection Certificate" if the candidate is working in any Govt./PSU, attached or subordinate organization, or any public body substantially funded by the Govt.

6. Schemes of selections:

- a) The selection process will consist of an interview of shortlisted candidates at discretion of the management, followed by a medical examination.
- b) Final empanelment will be subject to the candidate being found medically fit. The medical examination will be conducted by a medical authority designated by RailTel Corporation of India to assess the candidate's fitness for duties associated with the post. Candidates who do not meet the prescribed medical standards will not be considered for appointment.

- a.
